❖ **Vendor Stalls:**

- 10' frontage x 10' depth (approx.) / Wireless & one (1) 15 amp power plug, parking included.
- All Vendor Stalls must be paid for in advance of the show.
- Vendor display's containing a vehicle must be a min. of a 20' frontage per vehicle
- Selling booths be maintained and stocked during show hours and arrangements to do so can be made with a show coordinator.
- No alcohol allowed in building
- Vendor's must sign and follow all rules and regulations as stated in the Vendor contract
- Phone drops, extra electrical services and high voltage outlets required over the (1) 15-amp plug allotted must be purchase. This must be arranged prior to the show well in advance, thought the show co-ordinator (this is mandatory).

Your display **MUST NOT** be taken down until **after** the show closes on Saturday at 10:00 pm. The building will remain open until 12:00 am for your convenience but everything is to be removed from the building Saturday night after the show.

**PLEASE NOTE there is a trophy for "Best Dealer" Display.**

❖ **Set-up Times**

- Thursday March 29th – 3:00 pm till 11:30 pm & Friday March 30th – 7:00 am till 9:00 am

❖ **Show Hours**

- Friday March 30<sup>th</sup> & Saturday March 31<sup>st</sup> – 10:00 am till 10:00 pm

❖ **Pass Gate**

- Friday March 30<sup>th</sup> & Saturday March 31<sup>st</sup> – 7:00 am
- Vendors **must** enter the show through the pass gate Friday and Saturday

❖ **Vendor Passes**

- Your wristbands will be available upon registration at the show.
- Three (3) passes per Vendor Booth. All persons entering the building will need a pass or wristband to get past security at the door.
- *Extra passes may be purchased at a cost of \$5.00 ea. and must be arranged through a show Co-ordinator in advance of the show - Max. Quantity - 6 per vendor*
- **Wristbands must be worn securely on wrist.**
- Paper passes are good for one (1) day only and can be exchange for a wristband by coordinator.

**IMPORTANT!!!** – All vendors will be supplied a max. 3 SECURITY TAGS which are **MANDATORY** to be worn for **setup on THURSDAY**. If tag is not visible security will ask you to leave building!

**All vendor application fees MUST accompany vendor application and be paid in full.**
